Nevertheless, August did finally start to pick up with what appears to be a better second butterfly brood; we also enjoyed our final moth trapping session of the year which revealed a grey chi moth in Snowbottom Belt, near a lovely arable margin – only one was recorded in Gloucestershire last year so kudos to Nick and the team. The volunteers will return twice more this year in November and December to record winter birds and next year we are scheduled to visit Stones Farm. Water Voles: At the start of summer, we commissioned a water vole survey with the Gloucestershire Wildlife Trust; across the estate, GWT surveyed the lengths of the Sherborne Brook, Windrush and Leach. Water voles were recorded in 22 of the 28 surveyed areas with the highest levels of density recorded on the River Windrush between Windrush Mill and the Sherborne Brook, on the Sherborne Brook between River Windrush and Laughcroft and on the Sherborne Brook at The Broadwaters. Water vole was absent from the River Leach. Fundamentally this data reveals absence/presence and helps direct our conservation activity which can range from increasing water course margins to flow deflectors – American Mink control remains pivotal; however, no signs of mink were recorded which reiterates the importance of regular monitoring. Otters were recorded on the Sherborne Brook and River Windrush.
