Luke had a lovely moment at Sandy Hill earlier in the month where 100+ goldfinch exploded out of Matt and Laura's pasture – finches have had a tough time of late, but goldfinch seem to be doing well on Sherborne. Likewise, Starling, who have been darting around Lodge Park, Woeful Lake, and Home Farm on the South of the A40 – again, a bird in decline, but anecdotally we seem to be getting good numbers on that side of the estate. Redwing and fieldfare have returned in their droves this month;

We will also be working on dangerous sycamore, squirrel damaged beech limbs and coppicing through November.			
	October is our tree safety survey month, and the Rangers have been almost entirely devoted to this cause for the last six weeks – we have surveyed every			

	tree within striking distance of the A40, tenancies and local roads and some of our footpaths; this is a huge undertaking and not much else happens during October! We have recorded 186 trees/areas of woodland to work on – these tasks range from ivy cutting to aerial inspections to hulking (or monolithing) – ensuring the tree is safe and/or providing conservation value is of course our aim it is a challenging month, but a great opportunity to explore the estate and there really are some absolutely incredible tree specimens on Sherborne. The main takeaway for all of us was this is the year of the squirrel – We have never, ever seen squirrel damage quite as widespread and without prejudice as this before – every species of tree, of every age, seems to have taken a battering from their bark stripping tendencies; this will cause many headaches for rangers over the next few years.			
Volunteering	We continued work on restoring a small lost orchard in Sherborne Farm; stock-proofing this to utilise sheep as biological lawnmowers before planting. The team were also on loan to Bibury (another of our sites!) – we did some wildflower seeding in the Lodge Park meadow, ride management in Snowbottom belt, tidying and seeding of verges in Sherborne village and some work on a footpath diversion. In November, we have tree planting, coppicing, dangerous tree work, replacing and fixing benches in the Pleasure Grounds and removing/repairing fences and gates along Sabrina Way.
