Whoever has cut the hedges around the car park at Northfield Barn, has absolutely flailed some of the branches on the mature trees inside the wall – how can we stop this happening in the future?"	04/02/2025	Mareslaid Copse is in the Woodland Management Plan for the estate but there are no current plans to remove any timber from this area of woodland. The track along the North Park wall is an agricultural access track and needs to be kept clear to allow access. We will speak to our contractor to keep any impact on the mature trees to a minimum in the future.
25/5 – 26/1/25	"What actions are the Trust taking to stop sheep escaping onto public highways? It has become a weekly occurrence."	04/02/2025	We have a rolling program of fence replacements taking place across Sherborne Farm and working with our grazier. The new Delivery Manager will be working on this issue as a priority.
25/6 – 21/03/25	Wood chip path (Ewe Pens to Ragged Copse): Given the high cost (believe £5K per replacement) of sourcing the correct wood chip, are there plans to create a more permanent path to protect the wild plant margin? If not, could NT use or borrow a woodchipper to produce the required chip from fallen wood on the estate?	21/03/2025	It is an aim of the NT to replace the woodchip section of path with a surface similar to that of the paths through Ragged Copse. This will involve negotiations with our Tenant at Home Farm and will likely require planning permission following consultation with the Gardens Trust.
25/7 – 21/03/2025	Ragged Copse clearance: When will the runoff into Ragged Copse be cleared? Roadside grips can't be repaired until that's done	21/03/2025	The grips are planned to be cleared within the next month.

25/22 – 16/04/2025	What is the plan with the Poplar trees in Broad Close? Very disappointing if this is the finished job.	24/04/2025	The poplars were removed as part of our woodland management plan. These trees were planted up across the estate – and all over this part of Gloucestershire – as a timber crop for the old Bryant & May match factory. Poplars were planted wherever there was space.
			Unfortunately, the income from the timber did not make extraction economically viable. When this is the case, or when habitat value dictates, we leave the trees as standing 'hulks' to provide an extremely valuable decaying wood habitat. Admittedly, we don't always leave the stems as tall as here but there will be more work to follow, and they will be reduced further.
			We appreciate it looks a bit of a mess at present.
			Brash has been stacked but full clear up not carried out as there is more work to be done in Sherbrook Copse and future work will utilise some of this material.
			Information about future work will be shared soon but this whole area will look even more 'messy' in the short term whilst we enhance the wet woodland and establish an area of wetland. We manage the land for nature and the land will recover in time. Replanting with appropriate species will take place within a couple of years (following wetland work) and will provide a more aesthetically pleasing area of wet woodland."

25/24 - 14/05/2025	Perhaps for Luke, who we know has great ornithological knowledge. Can Luke comment about the habitat for Lapwings? Sherborne had just about the only Cotswold habitat for lapwings, but they were seen in the areas where there has been recent considerable tree planting. Does Luke expect them to remain, or will this habitat be lost? If so, what consideration was given when balancing this last remaining Lapwing habitat, against the tree planting?	23/05/2025	While designing this planting scheme we consulted widely on the plans, including with Cotswold National Landscape, and made several amendments as a result. Discussion also included Internal consultants, Ranger team and senior colleagues who provided management advice for the water meadows whilst working with the RSPB. Our decisions are taken at a landscape scale and looking at what Sherborne can deliver that is missing elsewhere in the landscape, in this case the extension/restoration of the historic wood-pasture habitat and the multiple benefits of this. We're also looking to create or enhance more open grassland/wetland habitat further south along the Windrush and the Sherborne Brook which may be better suited than the northern water meadows for waders in general where the valley is narrower, and there are already a lot of Poplars off our land, especially compared to the more open floodplains further south on the estate and north around Bourton, which seem much better for waders. whenever we make a decision to change land use, there are species that win and species that lose. We try as far as possible to manage for the maximum possible benefit. The density of planting in the 100 acre common field varies from low to very low across the site and includes many shrub species and large expanses of open ground.
25/25 - 14/05/2025	When will the signage for the Ice House be reinstated, as well as other signage in the park?	23/05/2025	No definitive date for this currently. We are currently working through it internally.
25/26 - 14/05/2025	Is there an update on the mirror for vehicle safety opposite the Water Meadows car park?	23/05/2025	We have liaised with Highways Gloucestershire and been informed that the installation of a mirror is not permitted. Their experience is that rather than improving safety a mirror could increase safety risks. They have provided the information below regarding the Safety risks of mirrors reflect light and interfere with a driver's vision-reduce the ability to judge an oncoming vehicle's speed-create an unreasonable dependence on the mirror-if dirty, distort or restrict the view-be an easy target for vandalsWe will explore other ways of improving visibility for vehicles exiting the car park.

NT said initially they would do this with left over stone from doing East Belt, which never happened, and again before Winter last year.
