Bridgeman landscape

This autumn/ winter we will be planting more trees and shrubs in the Charles Bridgeman landscape at Lodge Park.

This is being made possible through funding we secured through the National Grid Landscape Enhancement Initiative together with a generous donation from the former Cheltenham and Gloucester National Trust

Association.

We have begun marking out the next phases for planting, which will include 140 avenue trees and 15,000 trees and shrubs in three hectares of woodland blocks.

We will also be repairing gaps in the park wall on the north boundary.

Another 75 avenue trees will be planted next autumn/ winter, funded by the same project.



Fisherman's Bridge



We recently completed repairs to the Fisherman's Bridge, where it crosses the Sherborne Brook and enters the Broadwater.

In keeping with the original structure, the repairs were completed on a like-for-like basis. However, we have made some improvements to the handrail.

Later this autumn, we will be repairing the fencing either side of the bridge and adding some new pedestrian gates.

Fungi foray

Let estate update

Over the last couple of months, we have installed three new kitchens and one new bathroom. We have also installed secondary glazing in three more properties.

Dan has been working closely with the Conservation Officer and we are pleased to say that, in certain circumstances, we no longer require Listed Building Consent to install secondary glazing. We can therefore progress more quickly in those properties still requiring it.

There are still supply chain issues for secondary glazing, so we are unable to confirm exact timescales at the moment. To check if you are on the list for secondary

External decorations at some properties will be starting in October. Contractors will continue to work for as long as the weather allows. They will then be back in early spring to complete the properties that we surveyed this year. We will be adding more properties to the list for the summer.

Thames Water have been relining the sewage pipe through the village, as well as fixing the water leaks on National Trust land. We will soon be replacing one of the main private water pipes which runs up to Home Farm and Vincent's Lodge.

Woodland Management Plan

The Sherborne and Lodge Park woodland management plan is currently in the planning phase.

Within the next six months we will have gained all the necessary approvals and associated felling licences. Work will start next

autumn/ winter.

We also have lots of tree planting this winter to help us meet our national tree planting targets to fight the climate crisis.

Tree safety surveys are planned for this autumn. You will see us out and about assessing the higher risk zones later this month.



Project update

I have been at Sherborne for just over three months. It's been great getting to know the team and learning more about this amazing estate.


I have been carrying out many maintenance tasks with the outdoor team. This has ranged from watering trees, carrying out ash dieback surveys to strimming paths and repairing broken gates.

I am really excited to be heading into my favourite season of the year and seeing the autumnal colours Sherborne has to offer. I may even venture out on some fungi forays.

An exciting project I will be part of is our Heritage and Archaeology Ranger Team (HART). George our Area Ranger got the wheels turning on this and has now passed the baton onto me.

This team, once established and trained will visit the places we look after in the portfolio, surveying the archaeological features and condition scoring them.

This is a huge task. We will be starting with Sherborne this year due to the reliable



records of the features across the site. We'll then move on to focus on a different location within the Cotswolds.

Ash dieback

It has been a real pleasure spending the last few months working with James on the estate.

One of the principal tasks we've tackled in that time is the annual summer survey of Sherborne's ash trees and monitoring the impact of ash dieback.

Sadly, many of our ash are suffering from the fungal pathogen. High summer is a good time to check how badly affected they are.

The trees should be in full canopy, but those affected by the disease will have reduced leaf cover.

Once a tree has lost 50% of its canopy, it is severely affected and needs to be considered

for removal.

Between James and I, we have surveyed every ash that could fall on a path, road or building across the estate.

Unfortunately, the disease is hitting hard. We've had to mark-up many trees for removal. You may have seen those marked with pink paint.

This winter, contractors will be felling those that will pose the greatest risk.

We're keen to keep as many ash as possible; some individuals are resistant to the fungus. We don't want to fell trees that could produce healthy, disease-resistant offspring in the future.

It has been heartening to see some trees still thriving, dense with leaves and unaffected by dieback.

There is also some good news from the Bridgeman landscape.

Last winter, volunteers helped us to plant a new clump of small leaved lime.

James and I have carefully nurtured this clump over the drought and very hot summer weather.

Despite the testing conditions, we only lost one lime.

We're looking forward to the planting efforts to come this winter.



Lodge Park weekends

Wildlife wonders

This spring/ summer season a new wildlife monitoring programme, using an app to collect data, was trialled at Sherborne – with the help of some willing volunteers.

The focus was mammals, butterflies, reptiles and breeding birds.

I opted to carry out the trial on Sherborne Farm and our permissive walking routes.

We had a very successful season collecting data with over 10,000 entries logged.

I was disappointed that I wasn't able to carry out the bat and habitat surveys this year, due to my ankle injury. However, they will be included in my monitoring programme for 2023.
